# VII. AB 1237: Remedial Instruction Funding – Todd Giedt, Academic Senate Associate Director & Legislative Analyst

As amended, the bill states that any state monies beyond Prop 98 monies (e.g., "the minimum amount of funding be applied for the support of the public school system and community college districts") cannot be used for remediation. In short, this means that no state monies can be used for remediation at UC. The University is taking the position that UC does not do remediation, which is in part based on their reading of Academic Senate's Regulation 761.

Members will be asked to report on the impact of the budget situation on preparatory English and Math programs on their respective campus, with attention given to any areas of concern for UCOPE that might call for action by the committee in the future.
