Regulations of the Academic Senate University of California

Part III. Colleges, Schools, and Graduate Divisions

Title II. Curricula

Chapter 2. Requirements for the Bachelor's Degree

Article 1. General Requirements

636. University of California Entry Level Writing Requirement (Am 19 Feb 2004; Am Jan 2008)

- A. University of California Entry Level Writing Requirement is a reading and writing proficiency requirement. Each student must be able to understand and to respond adequately to written material typical of reading assignments in freshman courses. This ability must be demonstrated in student writing that communicates effectively to University faculty. (Am 30 Nov 83; Am 23 May 96; Am 19 Feb 2004)
- B. There are three ways a student may satisfy the University of California Entry Level Writing Requirement prior to enrollment at the University of California: by passing the University of California Analytical Writing Placement Examination, by attaining an acceptable score on another approved test of Writing, or by earning at least 3 semester credits or 4 quarter units of transferable college credit in English composition. (Am 19 Feb 2004; Am 30 Jan 2008)
 - 1. The content of the University of California Analytical Writing Placement Examination shall be approved by the University Committee on Preparatory Education, which shall also set the passing standard on the University of California Analytical Writing Placement Examination.
 - The list of approved tests of Writing shall be determined by the University Committee on Preparatory Education, with the concurrence of the Academic Council of the Academic Senate. The acceptable scores for each test of Writing shall be determined by the University Committee on Preparatory Education. (The current list of approved tests and the corresponding acceptable scores is on the <u>University of California</u>, Office of The President web site.)
 - The student must earn a letter grade of at least C in any transferable college English composition course used to satisfy the University of California Entry Level Writing Requirement. (Am 6 Mar 74; Am 28 May 80; Am 26 May 82; Am 30 Nov 83; Am 4 May 86; Am 23 May 1996; 30 Jan 2008)

- C. There are two ways a student may satisfy the University of California Entry Level Writing Requirement subsequent to enrollment at the University of California: by passing the University of California Analytical Writing Placement Examination, or by successfully completing a course or program of study approved for that purpose by an appropriate agency of the Academic Senate Division of the student's campus. (Am 28 May 80; Am 26 May 82; Am 19 Feb 2004; Am 30 Jan 2008)
 - 1. To satisfy the University of California Entry Level Writing Requirement by means of a course, the student must earn a C or above or its equivalent. A student who receives a final grade of C- or below has not fulfilled the University of California Entry Level Writing Requirement and may repeat the course(s). (Am 30 Jan 2008)
 - Any award of baccalaureate credit for University of California Entry Level Writing Requirement course(s) must be consonant with <u>SR 761</u>. (En 30 Nov 83; Am 19 Feb 2004; Am 30 Jan 2008)
- D. A student who has not satisfied the University of California Entry Level Writing Requirement prior to enrollment at the University of California must do so as early as possible during the first year in residence. A student who has not satisfied the University of California Entry Level Writing Requirement after three quarters or two semesters of enrollment will not be eligible to enroll for a fourth quarter or third semester. Exceptions to this requirement may be made by an appropriate agency of the Academic Senate Division of the student's campus. (Am 26 May 82; Am 23 May 96; Am 19 Feb 2004; Am 19 Feb 2004; Am 30 Jan 2008)
- E. Once enrolled at the University of California, a student must satisfy the University of California Entry Level Writing Requirement before earning transfer credit for the purpose of satisfying any subsequent University of California writing requirements by taking courses at other institutions. (Am 30 Jan 2008)

Bylaws of the Academic Senate University of California

Part II. - Universitywide Agencies and Committees

Title IV. Standing Committees of the Academic Senate

192. Preparatory Education (Formerly numbered 215) (Am 4 June 91; CC 28 May 2003)

- A. Membership shall be determined in accordance with Bylaw 128 and include one member appointed from the Board of Admissions and Relations with Schools (BOARS). One undergraduate student and one graduate student shall sit with the Committee. [See Bylaw 128.E.] The Vice Chair shall be chosen in accordance with Bylaw 128.D.2. and 3. (Am 28 May 2003)
- B. Duties. Consistent with Bylaw 40 the Committee shall: (Am 28 May 2003)
 - Advise the President and appropriate agencies of the Senate on matters relating to preparatory and remedial education, including the language needs of students from diverse linguistic backgrounds. (Am 28 May 2003)
 - 2. Monitor and conduct periodic reviews and evaluations of preparatory and remedial education.
 - 3. Supervise the University of California Entry Level Writing Requirement with special emphasis on establishing appropriate and uniform Universitywide standards for the University of California Analytical Writing Placement Exam [formerly called the Subject A Examination]. (Am 19 Feb 2004)
 - 4. Monitor the development and use of placement examinations in mathematics.
 - 5. Work with BOARS to communicate these standards to all high schools and colleges in the State of California.
 - 6. Monitor campuses' implementation of Senate Regulation 761.
 - 7. Facilitate the establishment of Divisional committees with comparable responsibilities, and promote communication between them.
 - Report on preparatory and remedial education to the Academic Council, the Assembly, and the other appropriate Senate agencies. (Am 30 Nov 83)

Welcome to the Senate's University Committee on Preparatory Education's SharePoint site. SharePoint is a web-based tool for on-line collaboration, information sharing, and documents with other committee members. The Senate will be utilizing SharePoint to maintain an on-line repository for agendas, annual reports, minutes, correspondence, and other documents that committees are actively working on.

SharePoint is a password protected site, so confidentiality and security are assured. To log-onto SharePoint, you only need your regular campus intranet log-in and password. The first time that you log-onto SharePoint, please select your campus, and enter your campus log-on and password at the prompts. If you have any trouble accessing SharePoint, please let me know. The URL for UCOPE's SharePoint site is: <u>https://sp2010.ucop.edu/sites/senate/ucope/default.aspx</u>. The URL for the Senate's main SharePoint site is <u>https://sp2010.ucop.edu/sites/senate/Pages/Default.aspx</u>.

Each committee's site contains a number of commonly-used links, along with the standard document libraries (Agendas, Annual Reports, Committee Correspondence, Draft Documents, and Minutes), which run down the upper left-hand side. To view any of these libraries, just click on the hyperlink. Once inside the library (e.g., Agendas), just click on either the icon or the hyperlinked item (in blue) to view the document (most will be in PDF format). You can either print the document out or save it to your hard drive. In addition to these standard libraries, your committee analyst may add other more specialized libraries (e.g., back-ground information on certain issues and/or historical information) as needed.

Besides the document libraries, SharePoint also has the ability to track committee tasks or projects, conduct surveys (electronic voting, etc.), and hosting discussions around certain topics (in lieu of email). Your committee analyst can provide more information on these specialized functions.
