BOARS Resolution on Programs or Policies that Guarantee Admission to UC December 2011

Whereas

- 1. The University of California was created and has been funded by California taxpayers, and the Master Plan for Higher Education envisioned priority access for California students;
- 2. UC is currently undergoing unprecedented growth in nonresident applications;
- 3. UC has guaranteed admission to highly qualified California residents to ensure their access as part of meeting its Master Plan obligation;
- 4. UC and its campuses are now receiving proposals for joint programs intended to prepare foreign students for transfer admission to UC, which in some cases would guarantee successful participants transfer admission;
- 5. UC and its campuses should not act too quickly in launching nonresident admission guarantees that could serious impact its Master Plan obligations;

Be it Resolved that

BOARS reaffirms existing policy that:

- 1. Programs or policies that guarantee freshman admission to the University of California or to a University of California campus must be limited to California residents (as does the current "9 x 9 guarantee").
- 2. Programs or policies that guarantee transfer admission to the University of California or to a University of California campus must be limited to students completing work at a California Community College (as do current TAG programs.)

In no way should this resolution be interpreted as restricting guarantees to AB 540 applicants who are considered as California residents.
