# Re: Proposed Revisions to Academic Personnel Manual (APM) Section 080, Medical Separation (Final Review)

Dear Mary,

The Executive Board of the UCLA Academic Senate discussed the proposed revisions to APM Section 080, Medical Separation at its meeting on April 16, 2015. The individual responses from our various committees are available <u>online</u>. Please pay special attention to those from the College Faculty Executive Committee.

While this is under "final review" and is not expected to lead to additional substantive changes, Executive Board members ask that it be clarified that the interactive process takes into consideration the time for the healing process, and further, that the disease should be stable before a decision is made.

Moreover, under 080-10, Procedures for Medical Separation Review, the reference to "shall attempt to consult, if possible..." should be revised to "shall consult", deleting the words "attempt to". A good faith effort to consult should be made.

And lastly, there is no differentiation made in the document between medical illness versus medical disability.
