#### **RE: UCOL Bylaw 185 Amendments**

Dear John,

As part of its discussions regarding the White Papers from the Special Committee on Scholarly Communication (SCSC), the University Committee on Library (UCOL) has held substantive discourse on its charge in the face of the rapidly evolving nature of scholarly communications. It is clear that scholarly communications is not only complex, but also quite broad. It encompasses a wide-range of subtopics, including escalating journal and monograph prices, faculty copyright, electronic communications, technology, and new venues for electronic publications. While UCOL commends the SCSC for its excellent work in bringing faculty attention to these issues, their white papers have also illustrated the need for long-term faculty oversight over scholarly communication.

Such oversight should be facilitated through a systemwide standing committee of the Academic Senate. The University Committee on Library (UCOL) is the appropriate location for such faculty oversight, as scholarly communications is very germane to the business of UCOL. As the introduction to the SCSC's white papers aptly notes, UC librarians have been involved in the management of scholarly communication from the beginning. UCOL has subsequently not only become familiar with these issues, but more importantly, it has gained a significant body of expertise in this area. Quite simply, the committee believes that scholarly communications cannot be divorced from faculty oversight and governance of the UC library system. While UCOL members would welcome the establishment of a special administrative task force to implement the work of the SCSC, they also feel that there is a need for long-term faculty oversight of scholarly communications, which UCOL is best equipped to handle.

Recognizing the challenges that scholarly communication raises, which are central to the mission of the University, UCOL proposes both a change to its charge as well as its name. Senate Bylaw 185, which governs UCOL, stipulates that the committee "advise the President concerning the administration of the libraries of the University in accordance with the Standing Order of the Regents." UCOL requests that this Bylaw be expanded to include oversight over scholarly communication. Second, UCOL would like to change its name from the "University Committee on Library" to the "University Committee on Library and Scholarly Communication" to reflect this expanded mandate.

Thank you for considering this request.

# Academic Senate Bylaw 185 Justification

#### **Statement of Purposes of Amendments to Bylaw 185:**

It has become increasing clear to UC faculty that the traditional models of scholarly communication have become unsustainable. From ever-increasing journal subscription costs, to new modes and venues of scholarly production, to heightened competition for both profit and non-profit publishers (such as university presses and scholarly societies), libraries have struggled to guarantee faculty members access to scholarly information. Reflecting this state of affairs, the Academic Senate established the Special Committee on Scholarly Communication (SCSC) to address these issues. Subsequently, the SCSC has submitted five white papers that not only expounded on these issues, but also proposed solutions to them.

These white papers have also illustrated the need for long-term faculty oversight over scholarly communication, which should be facilitated through a systemwide standing committee of the Academic Senate. The University Committee on Library (UCOL) is the appropriate location for such faculty oversight, as scholarly communications is very germane to the business of UCOL. As the introduction to the SCSC's white papers aptly notes, UC librarians have been involved in the management of scholarly communication from the beginning. UCOL has subsequently not only become familiar with these issues, but more importantly, it has gained a significant body of expertise in this area. In addition, scholarly communications cannot and should not be divorced from faculty oversight and governance of the UC library system.

## Statement of Intended Effect of Amendments to Bylaw 185:

The proposed amendment to Bylaw 185, which governs UCOL, would expand its charge to include oversight over scholarly communication. In its current form, Bylaw 185 limits UCOL to advising "the President concerning the administration of the libraries of the University in accordance with the Standing Order of the Regents." The proposed amendment would both expand UCOL's mandate to give it oversight over scholarly communication, and change its name from the "University Committee on Library" to the "University Committee on Library and Scholarly Communication" to reflect this expanded mandate.

## **CURRENT LANGUAGE:**

#### 185. Library

A. Membership shall be determined in accordance with Bylaw 128. One undergraduate student and one graduate student shall sit with the Committee. [See Bylaw 128.E.] The Vice Chair shall be chosen in accordance with Bylaw 128.D.2. and 3. A University librarian and the Chair of the Committee on Information Technology and Telecommunications Policy shall serve ex officio. (Am 7 May 87; Am 28 May 2003)

- B. Duties. Consistent with <u>Bylaw 40</u>, the Committee shall: (Am 28 May 2003)
  - 1. Advise the President concerning the administration of the libraries of the University in accordance with the Standing Orders of The Regents.
  - 2. Perform such other appropriate duties as may be committed to the Academic Senate by proper authority.

## **PROPOSED LANGUAGE**

## 185. Library and Scholarly Communication

- A. Membership shall be determined in accordance with Bylaw 128. One undergraduate student and one graduate student shall sit with the Committee. [See Bylaw 128.E.] The Vice Chair shall be chosen in accordance with Bylaw 128.D.2. and 3. A University librarian and the Chair of the Committee on Information Technology and Telecommunications Policy shall serve ex officio. (Am 7 May 87; Am 28 May 2003)
- B. Duties. Consistent with <u>Bylaw 40</u>, the Committee shall: (Am 28 May 2003)
  - Advise the President concerning the administration of the libraries of the University, and issues related to scholarly <u>communication</u>, in accordance with the Standing Orders of The Regents.
  - 2. Perform such other appropriate duties as may be committed to the Academic Senate by proper authority.
