APM 670 – Health Sciences Compensation Plan – Robert Raffai (UCSF) These changes were proposed after a targeted "management consultation" with relevant Senate committees and administrators. (They clarify certain principles such as authority levels, and add language to guide the assignment of Academic Programmatic Units to conform APM 670 to APM – 700). Comments due December 5.

APM 668 – Negotiated Salary Plan – Aland Buckpitt (UCD) New APM would allow a compensation model for general campus faculty similar to the health sciences compensation plan, which would provide the option for supplementing salary with non-state resources. Comments due December 5.

SR 610 (residency) – Donald Mastonarde (UCB) Comments due January 13.
