## CCGA Instructions to Divisional Graduate Councils: Conversion of Graduate Degree Programs from State-Supported to Self-Supported and from Self-Supported to State-Supported Status June 2011

CCGA has determined that the conversion of an existing graduate degree program from statesupported to self-supported status or from self-supported to state-supported status cannot be considered under the name change provisions in the Compendium. Such a conversion far exceeds those provisions.

State-supported graduate degree programs are designed to, and in fact do, operate to further the University's primary goals under the Master Plan. Self-supported graduate degree programs, by definition, serve an ancillary purpose. Frequently, a self-supported program's objective, at least in part, is to make the knowledge generated through the research activities of the faculty and students in state-supported programs available to those groups of students identified in the self-supported program policy. State-supported and self-supported programs are, therefore, not identical to each other in a number of significant ways. Consequently, existing graduate degree programs may not convert from state-supported to self-supported status or from self-supported to state-supported status.

Existing state-supported graduate degree programs may request their own disestablishment as statesupported degree programs in accordance with policy. Concurrently, faculty involved in the research, teaching, and administration activities of such existing state-supported graduate degree programs may present a proposal for the creation of a new self-supported program. All such proposals must comply with self-supported program policies.

Existing self-supported programs may request their own disestablishment as self-supported degree programs in accordance with policy. Concurrently, faculty involved in the research, teaching, and administration activities of such an existing self-supported program may present a proposal for the creation of a new state-supported program. All such proposals must comply with University policies.

Divisional Graduate Councils may, at their discretion, allow the disestablishment of the existing graduate degree program and the proposal for a new graduate degree program to proceed concurrently. CCGA may review both actions simultaneously and, at its discretion, on an expedited basis.
